Ordinances for Third and Final Reading

A. Ordinance #2018-13: An Ordinance Determining that Property Conveyed to the Borough in a Tax Foreclosure Proceeding Shall be Retained for a Public Purpose

The Borough aquired a small lot located at 313 Mitkof Highway through a tax foreclosure. Due to easements and a right-of-way recorded on the lot, along with the location of the property directly fronting Mitkof Highway, Borough staff believe the property is better suited for retention for a public purpose, rather than to be included in a land sale. Adoption of Ordinance #2018-13 will retain the property for a public purpose.

Ordinance #2018-14 will approve the Borough's FY 2019 Operating Budget. Note: an update to the proposed FY 2019 budget for the Electric Fund is requested in Finance Director Tow's memo, attached. This request will not change the total dollar amount of the Electric Fund's FY 2019 expenditures, but will change from where the funds will be allocated.

Ordinances for Second Reading

C. Ordinance #2018-15: An Ordinance Amending Petersburg Municipal Code Chapter 14.20, Entitled "Municipal Harbors", to Increase Harbor Fees

The Petersburg Waterfront Master Plan, adopted along with the Borough's Comprehensive Plan in March of 2016, recommended an across-the-board increase of 12% to harbor moorage and use fees to bring harbor revenues in line with costs. To accomplish this goal, a 10% prepayment provision was eliminated with the adoption of Ordinance #2017-03, moorage rates will increase by approximiately 9%, and most other harbor fees will increase by approximately 12% effective July 1, 2018 with the adoption of this ordinance.

Ordinance #2018-15 has been revised since its first reading to clarify fees for use of the launch ramps (see 14.20.390(B)(5) Launch ramp permit fee). All new language that has been added since the first reading of the ordinance is highlighted in blue.

Resolution #2018-02: A Resolution to Decide Where the \$464,711 to Finalize the Municipal Building Project Will be Transferred From (not the true title of the resolution, but there are two resolutions to choose from - Option A uses General Fund reserves and Option B uses part of the SEAPA rebate)

On January 4, 2016, the Borough Assembly approved Resolution #2016-01 which committed using up to \$1,300,000 in an interfund loan from the Electric Fund (with 1.5% interest) to help fund the Municipal Building Renovation project. The project is now complete, and rather than the \$1,300,000 approved, \$464,711 is needed to pay for the remainder of the project. Manager Giesbrecht and Finance Director Tow are suggesting to either use General Fund reserves or part of the recent \$685,158 SEAPA rebate to pay the project balance of \$464,711 rather than borrowing from the Electric Fund at 1.5% interest. At the January 16, 2018 Assembly meeting, the Assembly unanimously postponed action on this resolution until no later than the first meeting in June. The Assembly is provided with two versions of Resolution #2018-02 to choose from:

Resolution #2018-02(A) provides for use of General Fund reserves to pay the \$464,711.

Resolution #2018-02(B) provides for use of \$464,711 of the \$685,158 SEAPA rebate to pay the \$464.711. The remaining \$220,447 of the SEAPA rebate would go into the Electric Fund.

Resolution #2018-09 sets the millage rates for FY 2019. The area wide millage rate for FY 2019 is 4.35 mills, which is .05 mills less than in FY 2018; and, the Service Area 1 millage rate for FY 2019 is 11.38 mills which is .22 mills less than in FY 2018.

Attached to this agenda item is a copy of the April 18, 2018 letter the Borough sent to DNR requesting (for the second time) accurate maps for use in the Borough's municipal entitlement land selection process and a letter from DNR dated April 27, 2018. Community Development Director Cabrera is out of town currently, but she shared with Clerk Thompson that it is her understanding the April 27 letter from DNR is the only response the Assembly will receive to the Borough's April 18 letter, even though the April 27 letter relates more to the teleconference she and Manager Giesbrecht had with Martin Parsons, Deputy Director of DNR's Division of Mining, Land and Water. The April 27 letter from DNR clarifies that the Borough does not have to complete all land selections by October 1, 2018, and that the Borough has already met that deadline by submitting sufficient selections.

The Borough's bargaining team for the PMEA Collective Bargaining Agreement negotiations is requesting Assembly approval to implement the Borough's Last, Best and Final Offer presented to the PMEA membership in August of 2017.
