# 11. Report of Other Officers

# A. Updating the Borough Zoning and Subdivision Code

Community and Economic Development Director Cabrera explained that the Borough's existing zoning and subdivision codes have been in place since 1985 and have had no comprehensive updates since that time. Small changes to the code over the years have caused it to become contradictory to itself in places. Many of the processes (like applying for a Conditional Use Permit, for example) are cumbersome and slow. We currently have some zoning districts that do not conform to what is actually happening on the ground in that area, multiple zones on one piece of property, and different zones on either side of a street, all of which are not valid zoning practices. In addition, our newly adopted Comprehensive Plan contains key issues that will rely on new zoning codes to implement, such as maintaining the downtown attributes that we appreciate (covered sidewalks, business display windows along the sidewalks, local personality, etc.) and creating more moderate priced housing.

A new zoning and subdivision code will have reasonable timelines to streamline the application process, allow staff to handle minor applications, and be more clear. The framework for rewriting the code is a template that is used in small communities in Oregon and will create a code that is more user friendly.

The Planning Commission is currently reviewing portions of the code rewrite. Once the rewritten code is ready for public review, the Planning Commission will hold two public hearings before sending a recommendation to the Assembly for adoption.

## B. Petersburg Municipal Power & Light Capital Project Forecast

Petersburg Power & Light Superintendent Nelson presented a Capital Project Forecast for the utility. Future projects include a rewind of the Crystal Lake hydro generator, a system mapping upgrade, automatic meter reading capability in the harbors, replacement of the Scow Bay #2 stand-by diesel generator, replacement of downtown street lighting, conversion of street light bulbs to LED, replacement of the Libby Strait power poles with an underground line on the uphill side of the highway, replacement of the Sandy Beach pole line, conversion of the airport pole line to underground, and improvement of the power plant grounds to enhance maneuverability and expand parking.

Mayor Jensen read his report into the record and informed of a February 22, 2016 Senate Finance Committe meeting in which Anchorage Senator Anna MacKinnon advocated for severe cuts to the Alaska Marine Highway stating that Southeast residents can fly, drive, or use barges for their transportation options. Mayor Jensen requested permission from the Assembly to send a letter to Senator MacKinnon in response to her comments and shared that Petersburg has asked other Southeast communities to write letters as well. Ordinance #2017-02 was unanimously approved in its second reading.

B. FY 2018 Federal Project Priority List

Motion was made to approve a federal project priority list provided to the Assembly by Manager Giesbrecht that includes the following projects: Hospital, South Harbor ADA Ramps, Airport Bypass Road, Fram Street Retaining Wall and Utilities, Papke's Landing Dock, Housing Development (Airport Addition Infrastructure), Expansion of Emergency Radio System, Kupreanof Dock, Banana Point Improvements, Petersburg/Kake Road, South Harbor Parking Lot, and Pt. Agassi Dock Facilities. The main motion was amended to remove the Petersburg/Kake road from the list; however, the amendment failed by a vote of 4-3, Assembly Members Lagoudakis, Stanton Gregor, and Strand in favor. The main motion was again amended to add the Scow Bay Haul Out project to the list and to not list the projects in a priority order since there is virtually no funding at this time. If funding for a specific type of project comes available and we have such a project on our list, it wouldn't matter where the project fell in the priority list - we would still want to take advantage of the funding if possible. The second amendment was unanimously approved. The main motion, as amended, was unanimously approved by roll call vote.
