A. Ordinance #2016-02: An Ordinance Adopting the Comprehensive Plan
Dated February 22, 2016 for the Petersburg Borough

The Planning Commission recommends the adoption of the Petersburg Borough Comprehensive Plan dated February 22, 2016, with additions (Generalized Land Use Maps and Definitions, February 22, 2016, and Petersburg Waterfront Master Plan and appendices, February 22, 2016).

At the March 7 Assembly meeting, a motion passed to add the following wording to the Comprehensive Plan: "Any proposals to implement a land use code for areas outside of Service Area 1 should include an advisory vote of those people affected." After consulting with the Borough attorney and the Alaska Divison of Elections, it has been determined the "advisory vote of those people affected" wording is too expansive. Clerk Thompson suggested to the Assembly (via email) that Section 7.05 of the Borough Charter may cover this issue. Section 7.05 Planning and Platting within the Unincorporated Areas reads, "In the unincorporated neighborhoods within the borough, the assembly may establish, by ordinance, advisory committees for the planning, platting and land use regulation pertaining to the area encompassed by the respective neighborhoods. The assembly shall, by ordinance, establish the role and authority of each advisory committee." This allows the Assembly to call for letters of interest from outside of Service Area 1 residents willing to serve on an advisory committee that would hold meetings and gather public input from outside Service Area 1 residents and then report back to the Assembly if there were ever the desire to implement planning & zoning regulations outside of Service Area 1. Borough Attorney Heideman, via email, suggested that rather than an election, in addition to following Section 7.05 of the Borough Charter, a survey of landowners or registered voters located within the boundaries of the area in which zoning is contemplated could serve the same purpose.

This ordinance updates Section 7.04, Dogs, from City of Petersburg Code to Borough Code and moves fines for code violations to Borough Code Section 1.16.030, Fine Schedule. The following changes have been made to the ordinance since its First Reading; 1) the word "certified" has been struck out in the definition of "Service dog", and 2) Section 7.04.080 - Vaccination, the sentence, "Certification of vaccination must be presented prior to licensing." has been added.

Ordinance #2016-05 provides for the Borough's FY 2017 Operating Budget. Since the presentation of the proposed FY 2017 Budget on March 1, 2016, the following amendments have been made: \$180,000 in the current FY 2016 Wastewater budget (for Haugen Drive sewer lines) may not be incurred until later in the summer and therefore has been added to the FY 2017 budget, along with another \$30,000 requested for potential cost overruns, for a total of \$210,000.

Attached to this agenda item are the Balance Sheets requested by the Assembly from the entities asking for funds from the FY 2017 Community Services budget (Chamber of Commerce, Clausen Memorial Museum, KFSK, Mt. View Food Service, Petersburg Mental Health Services, and WAVE). Petersburg Mental Health has revised their funding request since the March 7 meeting from \$85,000 to \$75,000 asking that the Assembly consider providing the \$10,000 balance of the original request to WAVE for FY 2017.
