KFSK's Manager Tom Abbott is asking the Assembly adopt this Resolution requesting less severe cuts to public broadcasting than currently proposed for the FY17 State budget. KFSK endured a \$24,400 cut in funding in FY16 from FY15, and the current proposal before the Alaska Legislature would result in an additional \$31,000 cut in FY17 from FY16.
