Written authorization from the DNR has been received to erect and maintain a posting sign at the dock area of Papke's Landing. The resolution, if approved, will give authorization for staff to construct, erect and maintain the posting board. The public is advised that this posting board will not always carry timely postings due to its location. Posting will be made in conjunction with other work that the borough may be performing in the area. Resolution #2013-22 also provides for the Assembly to have the board removed if it is vandalized or becomes an attractive nuisance. The estimated cost to construct and install the posting board is \$750, with an annual maintenance and posting expense of approximately \$1,000.

Resolution # 2013-23: A Resolution Requesting the Governor and Legislature to Provide Significant Funding Increases to Repair, Replace and Maintain Transportation Modes Throughout the State
