Assembly Confirmation of Criteria to be Used During the Police Chief Search, Interview and Negotiation Stages Staff continues to work on hiring and interview criteria for the upcoming recruitment of a new police chief. A criteria update has been made part of this meeting packet for Assembly review. There are several items that require Assembly consideration at this time to keep the process on track. Those items are: 1) establish an annual salary (staff is recommending \$70 \$95,000 range); approve reimbursable moving expenses up to \$15,000; 3) appoint an assembly member to the formal Interview Board; and 4) authorize up to \$6,500 per month for a temporary contract for an interim police chief, if necessary. The assembly must also be prepared to conduct a Special Session near the end of April to affirm any hiring recommendation that may be made. Finally, because of the time of year a new police chief may come to town (June/July), assembly and community members are asked to keep their eyes and ears open for suitable housing.
