B. Approval of the Petersburg Waterfront Master Plan, 2015

Approval of the Petersburg Waterfront Master Plan, 2015: The Board reviewed the draft plan and a motion was passed to recommend to the Planning and Zoming Commission adopt the proposed 2015 Petersburg Waterfront Master Plan that included the following changes:

- 1) 3.4 Budget Constraints (pg. 18, paragraph 4): Combine first two sentences to read "Borough residents generally rely on local resources, harbor revenues, and State matching funds to finance harbor capital projects."
- 2) 5.5.5 Scow Bay Haul-out and Wash-down Facility (pg. 27, paragraph 3): Strike the rest of the paragraph after the first sentence, "As a Medium Priority, the Harbor Department should construct a new ramp at Scow Bay."
- 3) 6.1 Financial Considerations Summary (pg. 28, paragraph 4): Sentence 5 should read "Implementing an annual rate increase of the inflation rate plus two-percent over the next 10 years would provide additional revenues to allow the Port and Harbor Department to grow a replacement fund balance to a recommended balance of \$4.0 million (in 2015 dollars) over the long term."

Liz Cabera outlined the remainder of the Plan's review/adoption process and informed Harbor Board members that at the January 12, 2016 meeting the Planning Commission would suggest a date for the joint Harbor Board/Planning Commission meeting and public hearing.

A. Raw Fish Tax

Director Tow outlined the proposed funding for the Municipal/Police renovation that included the possibility of using a portion of the annual raw fish tax payment to pay back an inter-fund loan payment. She stated that the proposed loan is dependent upon many items and the final loan amount needed will not be known until project completion in approximately 15 months. Members of the audience and board members spoke against using the annual raw fish tax as a form of payment and requested that Liaison Wohlhueter carry this feeling back to the Assembly during their next discussion.
