Winter Reading Challenge: We exceeded our original goal of 30,000 minutes by 600%. 275 people signed up and 224 active readers read 211,059 minutes - making this our biggest program ever. We were among 40 libraries in the nation selected to win a cash prize. We were awarded \$500 which we will use for programming for all ages.

Planning is underway for the summer summer stream. Letters for donations will be sent out this month.
