7. PUBLIC HEARING ITEMS:

A. Consideration of an application from Mary Meucci for a variance from the 10' side yard setback requirement for the purposes of construction an 896 sf garage 5' from the property line at 11 West Lansing St. (PID: 01.011.076)

Patrick Valkenberg spoke on his own behalf to give clarification on the resubmission of the application. Mr. Valkenberg is the actual owner of the property and after making some changes to the original application, he resubmitted it and was not going to be available for the Commission meeting in December, hence having Mary Meucci act as their agent in their absence. But since the application got postponed, he is now here to answer any questions the commission may have.

Mr. Valkenberg stated that there is one error on his application, and that is on page 2, paragraph 3, 2nd line which states that the encroachment on the east side would be relieved. That is incorrect and should read that the encroachment would be on the south side. The south side is currently the back side of the garage which is 6" from the property line but the roof overhangs the adjacent property and dumps all the snow into the neighbors yard so that is one of the problems he is trying to correct. Regarding the size of the garage, Mr. Valkenberg stated that the size is necessary for the size of his boat which is what will be stored in there. Discussion.
