A. Commissioner Comments

Continuation of discussion on definition of "Automobile Repair Services, Major"

Commissioner Fry submitted some examples and recommendations of what he found on the web from other municipalities. Discussion. The Commission came to a consensus on using Commissioner Fry's proposed definitions, stating A) Auto Repair Minor: oil/filter change and lube; tune-up including sensor changing; upholstery; brake part replacement; U joint, CV joint or half shaft replacement; shocks or strut replacement; electrical system component repair or replacement; and similar repairs. All work must be conducted within an enclosed garage space. B) Boat Repair Minor: oil/filter change and lube; tune-up including sensor changing; upholstery; propeller replacement; water pump repair or replacement; control cable installation or replacement; electrical system component repair or replacement; and similar repairs. All work must be conducted within an enclosed garage space. C) Major Auto Repair: Anything not allowed in auto repair minor, including auto body and paint; welding; grinding or sandblasting; or any work that requires removal of the engine, transmission or other major component of the vehicle or requires specialty auto repair equipment, and D) Boat Repair Major: Anything not allowed in boat repair minor, including hull repair or painting; welding; grinding or sandblasting; or any work that requires removal of a major component of the vessel, requires large specialty marine repair equipment or can not be accomplished within a completely enclosed facility. Discussion.
